### **Summary:**

We collect your data (specifically outlined below, but generally basic information about you in a personal context such as email, gender and name, strictly to provide you with access to our news, events and other Romega UK promotions. We will not share this data with anyone unless you explicitly consent to us doing so. We honour your right to privacy and will comply with your wishes to remove your data from our systems.

### **Our commitment to privacy**

You deserve to know how we collect and use the data you provide to us, and that's what we are providing to you on this page. This notice applies to all information collected or submitted on the Romega-supplements website ([www.romega-supplements.co.uk](http://www.romega-supplements.co.uk)) and through our emails. This notice was updated on 5 June 2018 to reflect GDPR compliance standards.

### **How we use your information**

We use the data you provide to us for the following purposes:

- Provide you with access to the content and events we produce.
- Analyse profile or behavioural data to help us improve the products we offer you.
- In specific cases we will be contractually obligated to share your data with one of our third party advertisers or partners (for example, webinars, downloads or special events). We will never use or share the information provided to us online in ways unrelated to the ones described above.

Credit/debit card information (\*NOTE: we do not save or store this information, and it will only be shared with our payment processors in order to complete the transaction in which you are engaging.)

Based on the information you provide to us, we may create or append other information to your profile in the interest of better serving you (for example, your interests). As is the case with all data we collect, this will be kept private and for our business purposes only.
